THE TRANSFER OF DR. JUSTICE S. MURALIDHAR IS PUNITIVE

News of Dr. Justice S. Muralidhar's transfer from the Delhi High Court to the High Court of Punjab and Haryana came as an undesirable surprise to the lawyer in Delhi. Generally viewed as a courteous, yet firm, Judge Dr. Muralidhar treasures our Constitutional qualities and has consistently been a defender of free discourse and people rights. Consistent with his promise of office, he acted without fear or favor and was regarded for the equivalent respect with which he heard all matters. This clarifies the shock felt by all professionals which was reflected in the goals of the Delhi High Court Bar Association condemning transfer.

His transfer likewise filled in as an unwelcome reminder of the transfer of other similarly regarded Judges of the Delhi High Court a few years back. While one report proposes that Dr. Justice Murlidhar's transfer is a stage towards his arrangement as Chief Justice at the Punjab and Haryana High Court, there is nothing sound in the open area today to help this hypothesis. Different Judges have likewise been moved nearby Dr. Justice Muralidhar and these aggregate demonstrations of move are making professionals question the way toward moving Judges and prompting superfluous and unfortunate hypothesis inside the legal community.

Article 222 of our Constitution deals with the transfer of Judges and state that the President may, after consulting with the Chief Justice of India, transfer a Judge starting with one High Court then onto the next. This Article has been dependent upon broad judicial review and interpretation. And if transfers are based on "public interest" then does the public not have a right to know such reasons? For what reason should these reasons not be justifiable, particularly when the President declining mercy petitions

have been permitted to be challenged.

Capital City of India was burning because of tragic communal and political riots. Residents of Maujpur, Chand Bagh, Karawal Nagar and Gokupuri area were culprits as well as

victims of these clashes. Major issues behind theses riots were Anti- CAA Protest, Pro CAA and NRC Protest, Delhi Assembly Elections and Jamia Milia Incidents. Many people from minority community found the passage of CAA biased and discriminatory for Muslim Community whereas, many pro CAA supporters considered anti Citizenship Amendment Act Protest as Anti - National. It led to protest in Jamia Milia Islamia University and eventually ended as confrontation between police and students. This stroked communal fire between two religions.

Muslim Community alleges rally and address to audience by Kapil Mishra in Maujpur, as the reason behind Delhi clash whereas, Hindu Community holds minority community responsible for initiating violence. Pradhan said, protestors were allowing only vehicles of Muslims to pass through the blockade. They haven't allowed Hindu owner's vehicle to pass by their flock. Around 20 to 30 cars were set on fire by protestors. And, vehicle-owners were also beaten up. That's how it started from Maujpur and spread towards Brijpuri and Chand Bagh.

Aam Aadmi Party alleged Delhi Police's inaction as major drawback in controlling bloodbath. AAP leaders of affected constituencies blamed that,

cops of Delhi police initially some promptness but then left protestors to their fate. Reports indicated that Delhi police took no action to maintain peace despite being present at places of

report, 654 cases had been lodged by the Delhi police and 1,820 detained.

This is very rebukable that a country which is constitutionally secular has become culprit of communal clash in



mishap. Later on, Intelligence agencies deployed Paramilitary forces—Rapid Action Force (RPF) and Central Reserve Police Force (CRPF) on 23 February.

According to Chief Minister of Delhi Mr. Arvind Kejriwal, the attackers were not the local residents of that area. According to conclusions in aninitial report prepared by a delegation of the Delhi Minorities Commission, more than 2,000 outsiders or goons occupied two schools for 24 hours to execute the Delhi riots. And, as per a report of outlook, around 53 persons lost their life in riots. Eventually, Two Special Investigation Teams were formulated to execute an investigation on culprits and victims of Delhi violence. As per their front of United Nations and other countries. On 27th February 2020, CM of Delhi has declared free treatment for injured in both government and private hospitals. He also announced quid pro quos of Rs 10 Lakh for victims, Rs 5 lakh in case of minor's death and Rs 1 lakh ex-gratia and an immediate help aid of Rs 25,000 was also declared. But relief does not justifies bloodbath which took many invaluable lives. No Individual or association can bring can change there is a

communal reflection in Indian Politics.

DELHI RIOTS AFTERMATH: WHAT WE GAINED & WHAT WE LOOSE?

India's capital is grappling with the aftermath of the worst communal violence in Delhi in decades. More than 45 people, were killed in the clashes. Mobs swept through lanes targeting homes and set up roadblocks looking for attack. Crowds of Hindus and Muslims threw stones and petrol bombs.

The violence which unfolded as President Trump visited the city marks a major turning point for the nation and for the government of Prime Minister Narendra Modi.

Police are facing accusations from victims, witnesses, human rights groups, opposition politicians and Muslim leaders worldwide that they

failed to protect Muslim citizens, and in some cases, even incited attacks themselves. The United Nations High Commissioner for Human Rights has expressed "great concern," and the U.S. Commission on International Religious Freedom notes the allegations come amid "efforts within India to target and potentially disenfranchise Muslims."

The cruelty and the barbarity and the inhumanness it is both-sided, the way in which the intelligence officer was stabbed to death allegedly near a councilor's house was "something like what ISIS does." Tales of torture are being traded on both sides, ratcheting up fear, tension and trauma.

Which is the reason the role of the state machinery in failing to control the violence has come under the scanner. the police headquarters and administrative leadership in the home ministry need to answer some tough questions.

We also cannot deny with the fact that anti-CAA protests organized by Muslim groups in Delhi took a terribly violent turn, was seen as enough reason to allow local Hindu groups to retaliate with impunity.

The actual worry is that this Delhi riot may be only a trailer, and under the shade of this communal riot a big dangerous plan is

still going on.

- 1. On February 26th 2020, the Government of Sri Lanka rendered a formal draft to the United Nations, pertaining its willingness to withdraw from the United Nations Human Rights Council (UNHRC).
