Theme I – Global Pandemic a boon for Environment & Planet Myth or Reality

The threats discussed were related to the days post pandemic which will see the huge deployment of labor force to make up for the time lost. The High rate of production activities, carbon emission and generation of medical waste were the major threats perceived by the presenters

The biggest opportunities were found in the medical/pharmaceutical, healthcare and wellness industries. The researchers were of the opinion that the industries have done remarkably well during these days and will also do well in days to come. Research for a vaccine was also regarded as an opportunity by most of the researchers

Theme II – Sustainability and Growth of the Global Economy Post Covid-19: An Opportunity Threat Analysis.

Post lockdown the problems that the industries would face were related to that of labor force. The lack of labor force, reduced rate of production, imbalance in demand and supply etc. were the major threats mentioned by the researchers.

Researchers also came up with opportunities arising out of the pandemic which will pave way for further growth and help in reviving the economy. It discussed the various opportunities in the sectors like healthcare, pharmaceutical, agriculture, e-commerce etc. where a tremendous potential is waiting to get explored.

In the post pandemic era the non availability of workers can

be overcome by the local habitat to an extent. The opportunities in food sector are tremendous and the prompt home delivery service will also help in enhancing the business.

Use of information technology in Forensic evidence can enhance the working and bring about faster results. The idea of ODR (online Dispute Resolution) was another opportunity discussed broadly.
